I have worked with the student over the last year leading up to the submission of her EE. She worked hard to collate primary resources from her exhibition visit. Finally was successful in getting a response from family member of the artist to help answer some questions she had about Mati Klarwein's work. She worked hard to ensure her focus was the arts, although the essay was enhanced by her World religions knowledge as she worked hard to carefully select religious imagery which had a relationship with Klarwein's.
